- 5) Plot or Layout in part or whole, which is located in Public water body like channel / canal etc.,shall not be eligible for regularization.
- The Local Body shall regularise the individual plot by considering the least extent of ownership documents i.e., patta & sale deed document.
- 7) Plots/Sub-Divisions/Layouts shall be regularized under these rules only for Residential usage.
- 8) Before regularization of individual plots in the layout under reference the Local Body has to obtain a certificate or status report from the Tahsildar of the concerned taluk that, the layout is not obstructing the water ways on the common fields irrigation channels on the ground and flood level & inundation status.
